***Membership and subscription renewal notice for European Finance Association Members 2012***

***This letter contains important information not only about renewing your EFA membership but also about submitting to and registering for the 2012 EFA Conference – so please read all the information in this letter carefully***

Please note that as from 2012, Oxford University Press (OUP) will be managing the membership to the European Finance Association (EFA), as well as continuing to publish the journal and manage existing subscriptions to *Review of Finance*.

To renew your EFA membership and subscription to *Review of Finance* please return the enclosed payment advice. Any previous standing orders to the EFA will need to be cancelled with all payments for 2012 onwards sent to OUP, taking note of the rates overleaf. Please note that from 2012 membership will be charged in €EUR for members in Europe, \$USD for members in the USA and Canada and £GBP for members in the UK and the rest of the world. For your convenience full payment information is given on the reverse of the notice and payment may be sent to your nearest office as shown.

In this first year of transition we regret that it will not be possible for members to renew online. However, if we hold your email address you will be sent a secure link to renew your membership and subscription via the website next year.

We can confirm that this change does not affect your online access to *Review of Finance*. Membership to the EFA includes online access to *Review of Finance* content from 1996 onwards and will continue to be available via the OUP website using your existing username and password.
